APPALACHIAN YOUTH SERVICE (AYS)
ANNUAL REPORT OF FINDINGS
PREA Standard 115.388

Year Time Frame: October 2024 thru October 2025

The Prison Rape Elimination Act (PREA) was enacted to eliminate sexual abuse and harassment in confinement settings. PREA's implementing regulations, the "Final National Standards to Prevent, Detect and Respond to Prison Rape," were published by the Department of Justice and became effective on June 20, 2012.

Appalachian Youth Service provides community-based residential services for males from the ages of 9-21 with a 15-bed capacity. Appalachian Youth Service is licensed by the Pennsylvania Department of Human Services and abides by their regulations. Appalachian Youth Service has a zero policy for all forms of abuse, harassment, and retaliation. All allegations of abuse, sexual abuse, sexual harassment, and substantial risks of imminent sexual abuse are reported to ChildLine at 1-800-932-0313 or the Adult Protective Services Hotline (if over 18) at 1-800-490-8505.

To demonstrate compliance with PREA, juvenile facilities must be audited every three years. Appalachian Youth Service was last audited by a certified PREA auditor on August 5, 2021. This audit revealed that Appalachian Youth Service was "operating within the PREA Standards as established and do not require corrective action."
